Call to Order:

Mr. Plavnicky called the meeting to order at 6:02 p.m. All rose, Pledged Allegiance to the Flag. The recording clerk took a roll call attendance and a quorum was declared present. 3(P) 1(A)

Public Session:

Consideration of Minutes:

Mr. Novak points out a mistake under "new business". It reads "Mr. Novak says he will be going to a meeting and hopes to receive this grant." It should read "Mr. Novak says he will be going to a meeting and hopes to receive this permit."

Mr. Geruntho makes a motion to accept the minutes with the stated correction. Mr. Belardinelli Sr. seconded the motion. All in favor, so carried.

Superintendents Report:

Mr. Novak says Public Works is undertaking all crosswalks and stop bars. Mr. Novak says they are about 80% complete at this time.

Mr. Novak states beginning tomorrow 3 employees will be attending a supervisory training through the CT Technology Transfer Center and this will be a 1 day a week training lasting 6 weeks. Mr. Novak adds that this Thursday 4 employees are attending a one day flagger training to be certified flaggers. There will also be 2 employees attending a sign installation training. Mr. Novak says he will continue to give training to employees wishing to go. Mr. Novak says these trainings are very valuable.

Mr. Novak says a resident fell at the Transfer Station and he advised her to send all if any medical expenses to the city.

Mr. Novak states there was a ruling in favor of Public Works employees wearing shorts while at work in response to the Shorts Grievance made by employees. Beginning tomorrow employees are allowed to wear shorts.

Mr. Novak says material needs to be purchased for root control in sanitary pipes on 15 streets. Mr. Novak asks if this is a WPCA issue or Public Works. Mr. Geruntho asks who will put it in, Mr. Novak says it will be determined after a meeting with WPCA.

Mr. Geruntho made a motion to accept the Superintendents Report. Mr. Belardinelli Sr. seconded the motion. All in favor, so carried.

New Business:

Mr. Plavnicky asks the board to change the date of the November and December meetings. The November meeting will be held Thursday November 5, 2015 at 6:00 p.m. in the Aldermanic Chambers of Ansonia City Hall. The December meeting will be held Thursday December 3, 2015 at 6:00 p.m. in the Aldermanic Chambers of Ansonia City Hall.
