5. Total Interiors LLC- \$90,850.00

Mr. Cassetti makes a motion to accept the bid of \$90,850.00 from Total Interiors LLC. Mr. Geruntho seconded the motion. All in favor, so carried.

**Consideration of Bills:**

Mr. Plavnicky says a bill from WPCA does not make much sense and he would like to put it on hold until the bill can be better explained and investigated further.
