Special Meeting – August 9, 2011

Call to Order

The Special Meeting of the Ansonia Board of Aldermen was called to order at 6:45 p.m. by Aldermanic President Stephen Blume. All those present rose and pledged allegiance to the Flag of the United States of America.

1. Call of the Meeting

Alderman Sharkey MOVED to accept the call of the meeting; SECONDED by Alderman Adamowski. A voice vote was taken and the MOTION PASSED 9-0.

2. To fill a vacancy, the Board of Aldermen will vote to elect a registered voter as an Alderman in the Fifth Ward of the City of Ansonia in accordance with Section 143 of the City Charter.

Alderman Sharkey NOMINATED Howard Madigosky as an Alderman in the Fifth Ward; SECONDED by Alderman Duffus.

Alderman Sharkey stated, Howard has been a long time volunteer in the City of Ansonia, he most recently served, I don't know for how many years, on the WPCA he was the chairman for many years and I think he would be a benefit to this Board so I would like to place a nomination in the name of Howard Madigosky.

SECONDED by Alderman Duffus; President Blume asked three times if there were any further nominations; MOTION PASSED. President Blume asked three times if there were any further nominations. Being none, the nominations were closed on a motion by Alderman Danielczuk, seconded by Alderman Sharkey and unanimous.

A voice vote was taken and the MOTION PASSED 9-0 to elect Howard Madigosky of 43 Holbrook Street as an Alderman in the Fifth Ward of the City of Ansonia.

President Blume congratulated Mr. Madigosky as applause rang throughout the forum.

Alderman Howard Madigosky was immediately sworn in by Mayor James Della Volpe.

Alderman Sharkey MOVED to adjourn; SECONDED by Alderman Danielczuk. A voice vote was taken and the MOTION PASSED 9-0.
