Item 2- Request for a new up to date Police Policy Pension Quarterly Investment Review from Acting Comptroller Richard Bshara. **Chief Hale stated that he spoke with Mr. Chris Katchmar and he will be placed on the agenda for the February Board of Police Commissioners meeting to present the final report for 2013.**

NEW BUSINESS:

Chairwoman asked if the Board members wanted to continue to be part of the sub-committees they are currently in. All of the Board members agreed to stay in their current sub-committees.

CHIEF'S ORAL REPORT:

Personnel

Miscellaneous

- Budget meeting will be held next Thursday at 7pm at City Hall
- The Anti Crime Unit conducted a raid with the Department of Consumer protection and seized evidence. Another store was raided today and they ACU seized more evidence.

- An arrest has been made on the shooting case on Lester Street.
- A request was forwarded from the Mayor's office requesting a crosswalk on Columbia Street. Chief Hale asked that the Board look into the area.
- Major upgrades to the radio system should be completed tomorrow. This is including the Fire Department and ARMS.
- The heating project for the police department is complete and running well.
- The rifle program is set to begin later this month and it is a four day program that each officer must complete.

Chairwoman asked if the street near the YMCA will still have the right lane (doing downhill). Chief Hale responded yes the lane will remain.

Commissioner Heon asked Chief Hale if the stop sign located on Benz Street and Milan Street is necessary. Chief Hale stated he will talk to Lieutenant Cota to see if an adjustment needs to be made.

Commissioner Tyszka pointed out an increase in numbers on abandoned motor vehicles, disabled motor vehicles, and motor vehicle stops. Commissioner Tyszka stated that he would like to see these efforts to continue.

Commissioner Heon asked if there is anyway to push forward some of the recommendations from Marlin Controls. Chief Hale stated that copies of the report from Marlin will be given to the Board of Aldermen and the Board of Apportionment and Taxation and will be brought up in this year's budget season.

Commissioner Tyszka made a motion to accept Chief Hale's oral report. Commissioner Goldson seconded the motion. All in favor, motion carried.
