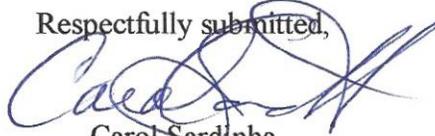
Mr. Moffat stated that there are no applications that needed to be addressed.
