Curbside Pick-up Policy and Procedures

TRANSFER STATION HOURS

Monday - Friday 7:00 a.m. - 2:45 p.m.
Saturday 8:00 a.m. - 11:45 a.m.
Open to ALL Ansonia residents for the disposal of bulk, brush or leaves - FREE!

WHO?

Any Ansonia resident or property owner with the exception of Real Estate Companies and Landlords who are in the process of selling or renting to new occupants.

HOW?

All Pick-ups must be "by appointment only" and limited to one free pick-up, which means persons must call Ansonia Public Works at 736-5945 during regular business hours, leave your name, address and brief description of items(s) to be picked up. Example: John Doe, 3 Smith Street, one TV, two appliances and one couch. The public works employee will tell you when to place it on the curb for pick up.

WHY?

Why is this necessary? To keep the City of Ansonia **clean**. Eliminating constant abusers and constant debris all over the City. Violators will be fined \$100.00 per day.

WHAT IS BULK?

What is curbside bulk pick-up? It is an item or items that can be disposed of safely, such as household appliances: refrigerators/freezers, stoves, dishwashers, furniture, bicycles, toys, etc. *Items that will not be picked up* ... demolition materials, rugs, decks or porches, bagged clothing, trash bags or boxes, car parts (batteries, tires, etc.) hazardous materials (paint, gas cans, oil, cleaners), asphalt, bricks, cinder block, concrete, cement, rocks, fencing, furnaces, hot water heaters, propane tanks, swing sets, swimming pools or mattresses. (*Residents may dispose of mattresses in the mattress container at the transfer station free of charge)

WHAT IS BRUSH?

Brush, tree limbs and shrubs must be neatly bundled in 4-foot lengths, tied or bundled.

Brush that will not be picked up . . . full trees or hedges, vines, tree trunks, logs or stumps. If you do have large quantities, full trees or have major amounts of landscaping debris, you can either bring it to the transfer station yourself or have your contractor bring it down with the proper permit (which you, the homeowner, can pick up at the transfer station prior to dumping) free of charge.

<u>PAPER-BAGGED LEAVES</u> will be picked up in the Spring and Fall by the same process. Please call in for appointment.

WHO IS NOT ELIGIBLE? This service is **not** for Landlords, Real Estate Brokers or Homeowners who are moving or are in the process of obtaining new tenants. Materials not covered under this agreement can be disposed of at the transfer station during regular business hours at the per-ton rate, payable upon dumping, by check ONLY. This policy is to benefit the taxpayers of the City, not to burden them.

<u>BULK AND BRUSH</u> will be picked up only during the six week period in the spring and fall. May 1st through October 31st each year. Pickups will be scheduled by appointment Tuesday through Thursday. Each address is entitled to one free pick up.

<u>CHRISTMAS TREES</u> will be picked up in January and February – please call for appointment.

<u>CLOTHING ITEMS</u> The City now has two clothing recycling bins located at the Public Works complex. You are encouraged to bring your clothing items to Public Works for disposal. The City will not pick up bagged clothing at any time during the course of the year.

NO PICK-UPS will be made in November, December, January, February and March and April, due to road maintenance, paving, snow removal and indoor building maintenance.

Violation of this procedure will be assessed at a **\$100.00** per day charge plus any expense, loss or damage occurred by the City in effecting removal as per Ansonia City Code Section 10.37.
